### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 02, 2025, placed the rating(s) of GSR Eco Bricks Private Limited (GEBPL) under the 'issuer non-cooperating' category as GEBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GEBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 18, 2026, March 28, 2026, April 07, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

GSR Eco Bricks Private Limited (GEBPL) was incorporated as a private limited company in February 2014, by Mr. Jagan Mohan Rao along with Sitaramamma. Mr. Jagan Mohan Rao is the managing director and looks after the day to day activities of the company. The company has its registered office in Prakasam (Dist), Andhra Pradesh. The company is engaged in manufacturing of Automated Aerated Concrete Blocks.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of GEBPL into ISSUER NOT COOPERATING category vide press release dated May 29, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
