Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 27, 2025, placed the rating(s) of Ganesh Saw Mills Private Limited (GSMPL) under the 'issuer non-cooperating' category as GSMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GSMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 12, 2026, April 22, 2026, May 02, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
