### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 24, 2025, placed the rating(s) of Ravindra Rice and General Mills (RRGM) under the 'issuer non-cooperating' category as RRGM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RRGM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 10, 2026, March 20, 2026, March 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the firm

Ravindra Rice and General Mills (RRGM) got established in 1998 as a partnership firm and are currently being managed by Mr. Ravinder Kumar Girdhar and Mr Sanjeev Kumar Girdhar. RRGM is engaged in the processing of paddy at its manufacturing facility located at Fazilka (Punjab). The firm is also engaged in milling for various government entities like PUNSUP, Pungrain, etc.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of RRGM into Issuer Not Cooperating category vide press release dated July 24, 2025 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of RRGM into Issuer Not Cooperating category vide press release dated May 25, 2026 on account of its inability to carry out a review in the absence of requisite information.

ICRA has continued the rating assigned to the bank facilities of RRGM into Issuer Not Cooperating category vide press release dated May 13, 2026 on account of its inability to carry out a review in the absence of requisite information.
