Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 11, 2025, placed the rating(s) of Shikhar Integrated Cold Chain Private Limited (SICCPL) under the 'issuer non-cooperating' category as SICCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SICCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 25, 2026, March 07, 2026, March 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Hathras (Uttar Pradesh) based Shikhar Integrated Cold Chain Private Limited (SICCPL) is a private limited company incorporated in 2012 and is promoted by Mr. Y.P. Singh, Mr. Amlesh Singh and Mr. Ashish Singh. SICCPL is engaged in procurement, cold storage and distribution of agricultural products such as lemon, ginger, carrot, pomegranate and apple.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SICCPL into Issuer Not Cooperating category vide press release dated November 12, 2025 on account of its inability to carry out a review in the absence of requisite information.
