### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 30, 2025, placed the rating(s) of Lokesh Advisory Private Limited (LAPL) under the 'issuer non-cooperating' category as LAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 16, 2026, March 26, 2026, April 05, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
