Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 26, 2025, placed the rating(s) of Shell-N-Tube Private Limited (SPL) under the 'issuer non-cooperating' category as SPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 11, 2026, April 21, 2026, May 01, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of SPL have been revised on account of non-availability of requisite information.

The company started its operations initially in Kolkata (West Bengal) and later on shifted its operations to Pune (since 1997). SPL is engaged in manufacturing of cryogenic tanks, cryogenic vaporizers and vacuum insulated pipelines, project consultancy, on site fabrication and installation & commissioning of cryogenic process equipment's at its manufacturing facility based in Wai, Maharashtra.
