Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 03, 2025, placed the rating(s) of Laxminarayan Spintex LLP (LSL) under the 'issuer non-cooperating' category as LSL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LSL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 17, 2026, February 27, 2026, March 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of LSL have been revised on account of non-availability of requisite information.

About the firm

Morbi, Gujarat based Laxminarayan Spintex LLP (LSL) was incorporated on December 02, 2021, by total 17 partners and 2 key partners viz. Mr. Pratik Kanasagara and Mr. Uday Patel. LSL has implemented a greenfield project to set up cotton spinning unit with 20064 spindles with an installed capacity of 5840 metric tons of cotton yarn of 26 count hosiery. It operates from its sole manufacturing facility at Morbi, Gujarat and has commenced its commercial operations from March 2024.
