Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 12, 2025, placed the rating(s) of B. K. Agro Products Private Limited (BKAPPL) under the 'issuer non-cooperating' category as BKAPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BKAPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 28, 2026, April 07, 2026, April 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of BKAPPL have been revised on account of non-availability of requisite information.

About the company

B.K. Agro Products Private Limited (BKAPPL) was incorporated on September 28, 2007. Since its inception, the company has been engaged in solvent extraction from rice bran, processing of agricultural products and rice milling business. The company's manufacturing plant is located at Paschim Midnapore in West Bengal.

BKAPPL procures paddy from the farmers and process rice under their own brand 'Trishul'. Apart from own rice milling, the company also does custom milling for government of West Bengal.

Status of non-cooperation with previous CRA: CRISIL has moved the rating assigned to the bank facilities of BKAPPL into ISSUER NOT COOPERATING category vide press release dated July 09, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
