Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 26, 2025, placed the rating(s) of Appollo Distilleries And Breweries Private Limited (ADBPL) under the 'issuer non-cooperating' category as ADBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ADBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 11, 2026, April 21, 2026, May 01, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Appollo Distilleries and Breweries Private Limited (erstwhile Appollo Distilleries Private Limited) owns and operates a brewery plant having an installed capacity of 50,000 KLPA (kilo litre per annum) at Billakuppam, Gummidipundi, Tamil Nadu (TN). The commercial operation of ADPL's manufacturing facility commenced in May 2012. The manufacturing facility was established at total cost of Rs.116 cr which was funded with term debt of Rs.75 cr and the rest in the form of equity from the promoters. Appollo Distilleries and Breweries Private Limited is the subsidiary of Empee Distilleries Limited (EDL) which is a part of Empee group. EDL is in the resolution process under Insolvency and Bankruptcy Code (IBC), 2016 as per National Company Law Tribunal (NCLT) order dated November 01, 2018. In accord with the Corporate Insolvency Resolution Process, the NCLT on January 20, 2020 has approved the resolution plan submitted by one of the resolution applicants with respect to EDL.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of ADBPL into Issuer Not Cooperating category vide press release dated September 22, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
