Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 30, 2025, placed the rating(s) of Pratibha Electrical Contractors LLP (PECL) under the 'issuer non-cooperating' category as PECL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PECL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 15, 2026, April 25, 2026, May 05, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
