### Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 29, 2025, placed the rating(s) of PCK Cotton Private Limited (PCPL) under the 'issuer non-cooperating' category as PCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 15, 2026, March 26, 2026, April 04, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company and industry

PCK Cotton Private Limited (PCPL) was incorporated in 1998 but started its operations in 2004 by Mr. Chetan Mehta, Ms. Geeta Mehta and Mr. Paras Mehta as a private limited company and is engaged in the business of cotton ginning and pressing. PCPL's plant is located at Jalgaon; Maharashtra and it has undertaken one more plant at Aurangabad on lease.

**Status of non-cooperation with previous CRA:** Infomerics has continued the rating assigned to the bank facilities of PCPL into Issuer Not Cooperating category vide press release dated August 01, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
