Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 16, 2025, placed the rating(s) of Sangam Rice Private Limited (SRPL) under the 'issuer non-cooperating' category as SRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 01, 2026, April 11, 2026, April 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Sangam Rice Private Limited (SRPL) was incorporated in 2007 as a Private Limited company and is currently being managed by Mr. Sanjiv Kumar and Mrs. Shubh Lata as its directors. The company is engaged in processing of paddy and milling of rice at its manufacturing facility located at Patran. The company is also engaged in trading of guar seed and rice.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SRPL into 'Issuer not-cooperating' category vide press release dated April 28, 2026 on account of non-availability of requisite information from the company.
