### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 07, 2025, placed the rating(s) of Fransko Agro Foods (FAF) under the 'issuer non-cooperating' category as FAF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FAF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 23, 2026, April 02, 2026, April 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Kerala based Fransko agro foods (FAF) is established as a partnership firm during April 2014 among the family members as partners. The firm is in to manufacturing of Rice, and processing of Spices, Coco and agro products. The firm was promoted by Mr.K.V.Francis along with his wife and sons as partners. Mr. K.V. Francis with his vast expertise in agriculture and food products industry has helped the firm to achieve market leader position over the span of few years. The firm has been awarded ISO 22000:2005 certification for its manufacturing facilities. The firm has its manufacturing facilities situated at Kalady, Ernakulum, Kerala with an installed capacity of 36,500 MTPA.
