Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 08, 2025, placed the rating(s) of East Hooghly Agro Plantation Private Limited (EHAPPL) under the 'issuer non-cooperating' category as EHAPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EHAPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 24, 2026, April 03, 2026, April 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of EHAPPL have been revised on account of non-availability of requisite information.

About the company

West Bengal based East Hooghly Agro Plantation Private Limited (EHAPPL) incorporated on December 03, 2015, was promoted by Mr. Krishna Chandra Mondal, Mr. Mainak Mondal, Ms. Anima Mondal, Ms. Munmun Pal, Ms. Jumpha Mondal and Ms. Mousumu Pal. The company had started its commercial operation from December 2016 onwards. The company has been engaged in manufacturing of High-Density Polyethylene (HDPE) fabric and woven sacks, used as covering products, thereby protecting them from moisture and dust. The manufacturing facility of the company is located at industrial area, Hooghly, West Bengal with an installed capacity of 1500MT per annum (HDPE Tarpaulin/Fabric and bag) and 2400 MT per annum (Leno Bag). Moreover, the company has not availed any moratorium on repayment of term loan and interest on working capital that could be availed under the terms of recent RBI circular.
