Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 19, 2025, placed the rating(s) of Marwar Carpets International(MCI) under the 'issuer non-cooperating' category as MCI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MCI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 05, 2026, May 15, 2026, May 25, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The firm is 100% Export Oriented Unit (EOU) engaged in the manufacturing and export of handmade carpets & rugs and have in-house handlooms for manufacturing the same and has weaving centre in Panipat, Haryana.
