Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 24, 2025, placed the rating(s) of Aggarwal Associates (AA) under the 'issuer non-cooperating' category as AA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 09, 2026, June 19, 2026, June 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Aggarwal Associates (AA) is a partnership firm established in 1995. It is currently being managed by Mr. Amit Garg and Mrs. Rimple Garg sharing profits and losses equally. AA is engaged in civil construction work in Haryana which includes infrastructure development and road work. The firm is registered as a class 'A' contractor with Public Work Department (PWD) of Punjab. The orders undertaken by the firm are secured through the competitive bidding process.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of AA into Issuer Not Cooperating category vide press release dated June 24, 2025 on account of its inability to carry out a review in the absence of requisite information.
