Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 18, 2025, placed the rating(s) of Balaji Pack and Pack Private Limited (BPPPL) under the 'issuer non-cooperating' category as BPPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BPPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 03, 2026, June 13, 2026, June 24, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Balaji Pack & Pack Private Limited (BPPPL) was incorporated in April, 2001 as a Private Limited Company by Mr. Bimal Kumar Sultania and his wife Mrs. Sarita Sultania. BPPPL is engaged in the business of manufacturing of electrical appliances i.e. Air coolers and auto parts.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of BPPPL into Issuer Not Cooperating category vide press release dated June 25, 2025 on account of its inability to carry out a review in the absence of requisite information.
