Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated June 16, 2025, placed the rating(s) of Dunac Motors Private Limited (DMPL) under the 'issuer non-cooperating' category as DMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 02, 2026, May 12, 2026, May 22, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Rating has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Bikaner-based Dunac Motors Private Limited (DMPL) was incorporated in 2004 by Mr Jagdish Dudi with an objective to commence automobile dealership business. Since inception, the company is an authorized dealer of Tata Motors Limited (TML) for heavy commercial vehicles. The company currently operates a sales, service and spare (3s) outlet at Bikaner and Nagaur. The overall management of DMPL is looked after by Mr Jagdish Dudi (Managing Director) who has an experience of around two decades in the automobile dealership business. Mr Jagdish Dudi is ably supported by his wife Mrs Kamlesh Dudi who has experience of around five years in automobile dealership business.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of DMPL into Issuer Not Cooperating category vide press release dated April 20, 2026 on account of its inability to carry out a review in the absence of requisite information.
