Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2025, placed the rating(s) of EMCO Electrodyne Private Limited (EEPL) under the 'issuer non-cooperating' category as EEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2026, April 30, 2026, May 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The entity was incorporated as a private limited company by the name of Emco Danubius Alternators India Private Limited in April 1994. However, in June 1995, the company was renamed to Emco Electrodyne Private Limited (EEPL) and is currently being managed by Mr. Piara Singh Matharoo, Mrs. Surinder Matharoo, Mr. J.S. Matharoo. The company is engaged in the manufacturing of motor coils, roebel stator bars, wound stator capsules, cast iron stator frame, generator, three phase induction motor and repairing/ rewinding & overhauling of generators and motors at its manufacturing facility located in Mohali, Punjab. Besides EEPL, the directors are also engaged in managing another group concerns namely Emco Switch Gears Private Limited and Emco Dynamics India.
