Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 23, 2025, placed the rating(s) of Golden Rock Granites Private Limited (GRGPL) under the 'issuer non-cooperating' category as GRGPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GRGPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 09, 2026, May 19, 2026, May 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of GRGPL have been revised on account of non-availability of requisite information.

About the company

Golden Rock Granites Private Limited (GRGPL), incorporated on September 22, 2004, is engaged in manufacturing of granite monuments. The company was originally established as a partnership firm under the name 'Golden Rock Granites' in 1995 and later reconstituted as a private limited company during 2004. Currently, the installed capacity of the company stands at 460 containers per annum with 21 MT per container.

These granite monuments find application mainly as tombstones and gravestones in cemeteries. The company has a track record of nearly two decades in the manufacturing of granite monuments and caters to Europe and USA markets.
