Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated July 15, 2025, placed the rating(s) of Achiever Apparels Private Limited (AAPL) under the 'issuer non-cooperating' category as AAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 31, 2026, June 10, 2026, June 20, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Achiever Apparels Private Limited (AAPL) (CIN No. U74899DL2004PTC123928) was incorporated in January 8, 2004. The company is currently managed by Mr. Harvinder Singh and Mrs. Appinderjit Kaur. AAPL is an export-oriented company engaged in the manufacturing and export of garments for women segment (Dress, tops, skirts, jackets, trousers, etc.). The manufacturing facility of the company is located at Gurugram, Haryana.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of AAPL into Issuer Not Cooperating category vide press release dated May 21, 2025 on account of its inability to carry out a review in the absence of requisite information.
