Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 25, 2025, placed the rating(s) of Poonia Wines Rewari (PWR) under the 'issuer non-cooperating' category as PWR had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PWR continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 10, 2026, June 20, 2026, June 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

PWR holds wholesale and retail liquor supplier license in the state of Haryana and undertakes wholesale and retail sale of Indian made foreign liquor (IMFL) and beer. The shops are allotted in Haryana by the state government through a competitive bidding process for a period of one year.
