Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 23, 2025, placed the rating(s) of East Hooghly Polyplast Private Limited (EHPPL) under the 'issuer non-cooperating' category as EHPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EHPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 08, 2026, April 18, 2026, April 28, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of EHPPL have been revised on account of non-availability of requisite information.

About the company

West Bengal based East Hooghly Polyplast Private Limited (EHPPL) incorporated in December 2009, was promoted by Mr. Krishna Chandra Mondal, Mr. Mainak Mondal, Mr. Kamal Pal and Mr. Bimal Pal. Since its inception, EHPPL has been engaged in manufacturing of different types of High-density polyethylene (HDPE) tarpaulins and fabric sheets used in the agriculture, construction, polymer and fertilizer industries. The manufacturing facility of the company is located at industrial area, Hooghly, West Bengal.

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of EHPPL into ISSUER NOT COOPERATING category vide press release dated September 11, 2025 on account of its inability to carry out a review in the absence of requisite information from company.
