Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated June 12, 2025, placed the rating(s) of SBS Transpole Logistics Private Limited (STLPL) under the 'issuer non-cooperating' category as STLPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. STLPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 28, 2026, May 08, 2026, May 18, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
