Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 01, 2025, placed the rating(s) of Mahaluxmi Steels (MS) under the 'issuer non-cooperating' category as MS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 17, 2026, May 27, 2026, June 06, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

MSL is mainly engaged in the manufacturing of iron & steel ingots and industrial rounds of various grades and sizes at its manufacturing facilities situated in Ludhiana, Punjab.
