Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 26, 2025, placed the rating(s) of Preet Land Promoters & Developers Private Limited (PLPDPL) under the 'issuer non-cooperating' category as PLPDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PLPDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 12, 2026, May 22, 2026, June 01, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Preet Land Promoters and Developers Private Limited (PLPDPL) was incorporated as a private limited company in November 2005 and is currently being managed by Mr. Raghubir Singh Dhiman, Mr. Charan Singh Saini and Mr. Kanwal Jit Singh collectively. PLPDPL is engaged in real estate business and is currently developing its first real estate project named- "Preet City" at Mohali (Punjab) on a total area of 100 acres. PLP commenced land acquisition for the project in 2006-07 (refers to financial year, April 1 to March 31).
