Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 04, 2025, placed the rating(s) of S S Poultries (SSP) under the 'issuer non-cooperating' category as SSP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 20, 2026, May 30, 2026, June 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

SSP has up a poultry farm spread over 5.5 acres at Ludhiana, Punjab. The firm has two group concerns- Anand Poultry Farm and S R Poultries, which are also engaged in the similar line of business, since 2009 and 2014, respectively.
