Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 27, 2025, placed the rating(s) of Renuka Poultry Farm (RPF) under the 'issuer non-cooperating' category as RPF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RPF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 12, 2026, April 22, 2026, May 02, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Karnataka based, Renuka Poultry Farm (RPF) was established in the year 1998 as a proprietorship firm and promoted by Mr. P Bhadrappa. Later on, the proprietorship firm was converted into partnership firm in July 2014. Currently, RPF is managed by Mr. P Bhadrappa and Mrs. P Rajya Lakshmi (Spouse of Mr. P Bhadrappa). The entity is engaged in farming of egg laying poultry birds (chickens) along with trading of eggs and cull birds. The firm sells its products like eggs and cull birds mainly in Karnataka, Maharashtra and Goa to retailers through own sales personnel and through some dealers.
