Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 02, 2025, placed the rating(s) of Satchidananda Agro Tech Private Limited (SATPL) under the 'issuer non-cooperating' category as SATPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SATPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 18, 2026, March 28, 2026, April 07, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings. opinion is not sufficient to arrive at a fair rating.

About the company

Satchidananda Agro tech Pvt Ltd (SATPL) was incorporated in May 2013 by Shri Vijay Kumar Maroti, Shri Narendra Kumar Chhajer and Shri Sandip Maroti based out of Burdwan, West Bengal. The company is engaged in the processing and milling of rice. The milling unit of the company is located at Burdwan, West Bengal with processing capacity of 35,000 Metric Tonne Per Annum (MTPA). The day to day affairs of the company are looked after by all the four directors, with adequate support from other directors and a team of experienced personnel.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SATPL to 'Issuer Not Cooperating' category vide press release dated June 13, 2025 on account of its inability to carry out a review in the absence of the requisite information from the Company.
