Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 16, 2025, placed the rating(s) of Jayoti Vidyapeeth Women's University (JVWU) under the 'issuer non-cooperating' category as JVWU had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JVWU continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 01, 2026, June 11, 2026, June 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

JVT operates Jayoti Vidyapeeth Women's University (JVWU), which is India's first, women's private state university established and incorporated under the Act 17 of 2008 passed by Rajasthan State Legislature and notified by government of Rajasthan in 2008.
