Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 04, 2025, placed the rating(s) of R S Contractors (RSC) under the 'issuer non-cooperating' category as RSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 20, 2026, May 30, 2026, June 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the firm

Lucknow based R. S. Contractors (RSC) was established in 2012 as a partnership firm. The firm is currently managed by its partners Smt. Rashmi Yadav and Mr. Brij Kishor. The day -to-day operations of the firm are managed by Mr. Subodh Yadav, Husband of Smt. Rashmi Yadav. RSC is a registered class 'A' contractor which enables the firm to participate in higher value contracts floated by the various government departments. It is engaged into civil construction projects awarded by Public Works Department (PWD), Uttar Pradesh Avas Evam Vikas Parishad (UPAVP) and other state government authorities of Lucknow, Kanpur, Mainpuri, Sitapur and other regions of Uttar Pradesh state.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of RSC into Issuer Not Cooperating category vide press release dated May 27, 2025 on account of its inability to carry out a review in the absence of requisite information.

Brickwork has continued the rating assigned to the bank facilities of RSC into Issuer Not Cooperating category vide press release dated August 05, 2025 on account of its inability to carry out a review in the absence of requisite information.
