Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated July 09, 2025, placed the rating(s) of Cold Steel Corporation (CSC) under the 'issuer non-cooperating' category as CSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 25, 2026, June 04, 2026, June 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
