Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 04, 2025, placed the rating(s) of Kisan Ginning & Pressing (KGP) under the 'issuer non-cooperating' category as KGP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KGP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 20, 2026, May 30, 2026, June 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Kisan Ginning & Pressing (KGP) is a Chandrapur based, partnership firm, established by Mr. Radhesham Adaniya and Mr. Gopal Adaniya in 2014. The entity is engaged in the business of cotton ginning & pressing and extraction of oil at its manufacturing facility located at Chandrapur, Maharashtra.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KGP into Issuer Not Cooperating category vide press release dated August 11, 2025 on account of its inability to carry out a review in the absence of requisite information.
