Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 24, 2025, placed the rating(s) of Newshubham Stone Crusher LLP (NSCL) under the 'issuer non-cooperating' category as NSCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NSCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 10, 2026, May 20, 2026, May 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
