Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 05, 2025, placed the rating(s) of Bharat Sheet Grah Private Limited (BSGPL) under the 'issuer non-cooperating' category as BSGPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BSGPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 21, 2026, May 01, 2026 and May 11, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Bharat Sheet Grah Private Limited (BSGPL) (CIN No.U15139UP2008PTC034537) was incorporated in January, 2008 and started its commercial operations in March, 2013. The company is currently managed by Mr. Kaushlendra Kumar Gupta & Mr. Arvind Kumar Gupta. BSGPL is engaged in renting of its cold storage facility for potatoes to the local farmers in Sirsaganj, Uttar Pradesh. The company has two group associates namely; "Sai Sheet Grah"; (established in 2000) engaged in renting of its cold storage facility and "Sai Rice Mill"; engaged in rice milling.
