Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated July 08, 2025, placed the rating(s) of Akshat Roller Flour Mills Private Limited (ARFMPL) under the 'issuer non-cooperating' category as ARFMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ARFMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 24, 2026, June 03, 2026, June 13, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of ARFMPL have been revised on account of non-availability of requisite information.

ARFMPL, incorporated in September 2002, is engaged in the production and sale of various agro food products including Maida (refined flour), Atta (wheat flour), Suji and Choker. ARFMPL has its manufacturing facilities located at Varanasi, Uttar Pradesh. The company sells its products under the brand name of 'Health season'.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of ARFMPL into Issuer Not Cooperating category vide press release dated May 13, 2026 on account of its inability to carry out a review in the absence of requisite information.

ICRA has continued the rating assigned to the bank facilities of ARFMPL into Issuer Not Cooperating category vide press release dated January 22, 2026 on account of its inability to carry out a review in the absence of requisite information.
