Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 25, 2025, placed the rating(s) of Bhanwar Singh Rathore (BSR) under the 'issuer non-cooperating' category as BSR had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BSR continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 10, 2026, June 20, 2026, June 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
