Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 09, 2025, placed the rating(s) of Sai Babuji Projects Private Limited (SBPPL) under the 'issuer non-cooperating' category as SBPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 25, 2026, May 05, 2026, May 15, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Hyderabad based, Sai Babuji Projects Private Limited (SBPPL) was incorporated in August 2011 by Mr. Sreekanth Mallela and Mrs. Bhuvaneshwari Mallela. The company is engaged in system integration i.e. supply, installation and commissioning of solar water pumping systems since 2014. The company has its customer base spread across Telangana, Tamil Nadu, Andhra Pradesh, Chhattisgarh, and Gujarat.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SBPPL into Issuer Not Cooperating category vide press release dated June 13, 2025 on account of its inability to carry out a review in the absence of requisite information.

Infomerics has continued the rating assigned to the bank facilities of SBPPL into Issuer Not Cooperating category vide press release dated April 11, 2025 on account of its inability to carry out a review in the absence of requisite information.
