Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated June 16, 2025, placed the rating(s) of Grace Jewels Private Limited (GJPL) under the 'issuer non-cooperating' category as GJPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GJPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 02, 2026, May 12, 2026, May 22, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The company is engaged in the business of manufacturing of gold, diamond and colour stone studded jewellery. Mr. Vikash Golechha and his wife Mrs. Vidya Golechha are the directors who manage the business for more than a decade. The company deals mainly in 24 carat gold jewellery and diamonds of all shapes, sizes and cents. GJPL has its processing unit with an annual installed capacity of 60 kg of jewellery in Mumbai, Maharashtra.
