Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 28, 2025, placed the rating(s) of Baba Baidnath Spinners Private Limited (BBSPL) under the 'issuer non-cooperating' category as BBSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BBSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 14, 2026, April 23, 2026, May 03, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

BBSPL is engaged in the manufacturing polyester yarn. It procures material i.e. fibre staple from domestic suppliers and sells its products to the garment manufacturers situated in Surat and Mumbai.
