Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 08, 2025, placed the rating(s) of Om Sai Resorts (OSR) under the 'issuer non-cooperating' category as OSR had failed to provide information for monitoring of the rating agreed to in its Rating Agreement. OSR continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 24, 2026, June 03, 2026, June 13, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Om Sai Resorts (OSR) is a Goa based proprietorship, engaged in setting up a 38 rooms hotel owned by Mr. Akshay Govekar. The hotel is proposed to operate in an area of 2125 sq mt and have facilities viz. multispecialty restaurant, banquet hall, swimming pool, banquet hall, gym and others along with stay facility. The hotel is proposed to have 38 AC rooms comprising of 35 standard rooms and 3 luxury suites for stay purpose.
