Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 13, 2025, placed the rating(s) of Rao Bharat Singh Education Society (RBSES) under the 'issuer non-cooperating' category as RBSES had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RBSES continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 29, 2026, May 09, 2026, May 19, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The society operates a school under the name of RBSES located in Gurgaon, Haryana was established for providing primary and secondary education from Nursery to standard XII. However, currently they have students up to XIth standard only.
