Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 20, 2025, placed the rating(s) of Bina Khimlasa Malthon Toll Roads Limited (BKMTRL) under the 'issuer non-cooperating' category as BKMTRL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BKMTRL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 06, 2026, May 16, 2026, May 26, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Bina Khimlasa Malthon Toll Roads Limited (BKMTRL) is a Special Purpose Vehicle (SPV) floated by EIL for construction of a 2 - lane toll road Bina-Malthon section, a 39.72 km road section, in the state of Madhya Pradesh under Build, Operate & Transfer (BOT) basis. The project was awarded to BKMTRL by Madhya Pradesh Road Development Corporation Limited (MPRDC), a public sector undertaking. The scope of work for the project highway includes construction, operation and maintenance for a period of 25 years including a construction period of 2 years commencing on the Appointed Date i.e. February 26, 2010.x
