Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated June 30, 2025, placed the rating(s) of MBC Infra-Space Private Limited (MIPL) under the 'issuer non-cooperating' category as MIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 16, 2026, May 26, 2026, June 05, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Vapi (Gujarat) based, MIPL was established as private limited company in year 2012 by Mr. Manoj Barua and Mrs. Bobby Baruah. The company is based at Vapi and is primarily involved in business of industrial civil construction and has carried out various projects such as civil work for construction of Industrial shed and other industrial civil construction. Also, Mr. Manoj Baruah is also associated with a proprietorship firm named MB Corporation since 1999.
