Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 08, 2025, placed the rating(s) of Hanuman Dal Industries (HDI) under the 'issuer non-cooperating' category as HDI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HDI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 24, 2026, June 03, 2026, June 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The promoters operate other group entities viz Hanuman Rice Industries, Shree Laxmi Tirupati Amma Murmura Industries, Balaji Industries, Tirumala Dal Udyog and Adinath Cold Storage Private Limited. The firm is engaged in processing & milling of pulses (tur and chana dal) and sale of its by-products in the domestic market. The processing unit is located at Kamptee, Nagpur.
