Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 12, 2025, placed the rating(s) of DH Limited (DL) under the 'issuer non-cooperating' category as DL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 28, 2026, April 07, 2026, April 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Ghaziabad-based (Uttar Pradesh) DH Limited (DL) (formerly known as Dass Hitachi Limited) established in 1960, is a closely held public limited company. DL was originally formed under the joint venture between Mr S.K. Dass and Japan based Hitachi Limited to manufacture electric watt-hour meters. The name changed to the present one in January, 2014, after the separation from Hitachi Limited. The current management comprises of Mr SK Dass, his wife Ms Veena Dass and son Mr Pradeep Dass. DL is engaged in manufacturing of engineering goods specifically defence systems viz. cableway and specialized systems. These specialized systems include NBC integrated shelters, NBC ventilation system, bullet proofing of vehicles, laboratory on wheels and many other medium and high technology precision products to cater to the needs of defence forces. The company is also engaged in providing fabricated metal products. DL has its manufacturing unit located in Sahibabad, Uttar Pradesh and the processes of the company are ISO 9001:2008 certified.
