Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 29, 2025, placed the rating(s) of K. P. Saha Private Limited (KPSPL) under the 'issuer non-cooperating' category as KPSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KPSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 15, 2026, March 26, 2026, April 04, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KPSPL have been revised on account of non-availability of requisite information.

About the company

Incorporated in January 1989, K.P. Saha Private Limited (KPSPL) was promoted by the Saha family of West Bengal. The company owns a rice milling and processing unit namely 'Maa Bameswari Rice Mill' which started operations from December 2010. The rice milling unit of the company is located at Dhaniakhali, West Bengal with an aggregate installed capacity of 28800 metric tonnes per annum. The company also owns a cinema hall 'Sangam Cinema' at Kalyani, West Bengal. Moreover, the company has not availed any moratorium on repayment of term loan and interest on working capital that could be availed under the terms of recent RBI circular.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of KPSPL into Issuer Not Cooperating category vide press release dated December 10, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
