Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 09, 2025, placed the rating(s) of Seven Hills Educational and Health Care Society (SHEHCS) under the 'issuer non-cooperating' category as SHEHCS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHEHCS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 25, 2026, April 04, 2026, April 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The society is running educational institution in the name of Seven Hills Educational and Health Care Society (SHEHCS) at Sambalpur, Odisha. The Institute has intake sanctioned capacity of 2500 students for Central Board of Secondary Education (CBSE) and 250 students for Council of Higher Secondary Education (CHSE) for the academic year 2018-2019. SHEHCS is engaged in the construction of new administrative building with total area of 2,00,000 square feet.
