Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 03, 2025, placed the rating(s) of Blue Ocean Beverages Private Limited (BOBPL) under the 'issuer non-cooperating' category as BOBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BOBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 19, 2026, April 29, 2026, May 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of BOBPL have been revised on account of non-availability of requisite information.

Bangalore based Blue Ocean Beverages Private Limited (BOBPL) was incorporated in 2007 as a Private Limited Company by Mr. P C Joseph George and Mr. Albin P Mathew. BOBPL is into manufacturing and bottling of Indian Made Foreign Liquor (IMFL) and manufacturing facility located at Goa.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of BOBPL into ISSUER NOT COOPERATING category vide press release dated March 11, 2026 on account of its inability to carry out a review in the absence of requisite information from the company.
