Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated June 13, 2025, placed the rating(s) of Bagh Bahar Appliances Private Limited (BBAPL) under the 'issuer non-cooperating' category as BBAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BBAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 29, 2026, May 09, 2026, May 19, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

Analytical approach: Standalone revised from Combined

Previously CareEdge Ratings had taken a combined view for the ratings assigned to Bagh Bahar Appliances Pvt Ltd (BBAPL) with its group companies viz. SSK Retail Pvt Ltd (SRPL), SYSKA Led Lights Pvt Ltd (SLLPL), Shree Sant Kripa Appliances Pvt Ltd (SSKAPL), SSK Infotech Pvt Ltd (SIPL) and SYSKA E Retails LLP (SEL), collectively called as 'SSK Group', as they have financial and operational linkages including intercompany transactions and financial support offered to each other along with corporate guarantees given for facilitating bank debt. However, updated information is not available to ascertain financial and operational linkages that warrant a continuation of combined approach.

BBAPL is a closely held private limited company and dealer of the flagship company SSKAPL. BBAPL is also the exclusive distributor for Samsung home appliances in Jalgaon, Aurangabad, Pune, Satara and Sangli in Maharashtra, and in Goa and mobile distribution in Pune.

Status of non-cooperation with previous CRA: Acuite has continued the rating assigned to the bank facilities of BBAPL under Issuer Not Cooperating category vide press release dated April 07, 2026 on account of its inability to carry out a review in the absence of the requisite information from the company.
